We provide a forum for exchanging ideas, learning about new research methods, and improving the quality of research for junior and senior scholars. Further, our members study a broad range of topics related to information technology in the healthcare field. Over the past two years, as chair, Cindy LeRogue has successfully directed the growth and success of the group, ensuring its prominence within the Association for Information Systems (AIS). A recent audit of AIS Special Interest Groups by the Vice President of SIGs and Chapters ranked SIGHealth first out of some thirty plus different groups, attesting to the accomplishments achieved over the past years.

The strength of our organization uniquely positions us to take advantage of the growing interest among academics in information technology within the healthcare field. In addition, the current healthcare debate within the United States has heightened the focus of practitioners and consumers on the role of technology in both care delivery and management. Cumulatively, SIGHealth should capitalize on its solid foundation in continuing to foster the efforts of healthcare information technology scholars as well as those newly joining the fold within the AIS and beyond its borders. Our group needs to continue the strong tradition of supporting special issues in top journals as well as tracks and sessions at leading conferences. Moreover, we should look for opportunities to sponsor workshops, potentially on a recurring basis, like the session held this past summer at the America's Conference on Information Systems in San Francisco. Such events give the group a readily identifiable tradition within the community, further solidifying SIGHealth's role.

AMIA "10x10"... Jim Ryan

In 2005, the American Medical Informatics Association (AMIA) launched its 10x10 Program, with the objective of training 10,000 healthcare professionals in applied health and medical informatics by the year 2010. The 10x10 Program focuses on work force challenges related to electronic health record management and nationwide health information infrastructure. In the same year, AMIA partnered with the Oregon Health and Science University (OHSU) to launch its inaugural 10x10 distance learning course. The adaptation of an existing OHSU introductory course in healthcare informatics, delivered through a distance learning channel, provides exposure of the field to a wider audience. Moreover, some aspiring students within the audience matriculate to more advanced studies in graduate academic programs. Hersh and Williamson (2007) documented the inaugural 10x10 course success in the *International Journal of Medical Informatics* and AMIA currently partners with eight other academic institutions across the United States. AMIA also offers an internationally-focused variation of the successful 10x10 Program called *i*10x10. AMIA invites proposals from qualified educational institutions to offer courses in its 10x10 Program and approved academic partners must comply with common AMIA criteria guidance. Each of the current partner's courses has similar structure where the course is delivered via distance learning (11 to 15 weeks depending on the partner institution), culminating in an in-person session conducted in conjunction with an AMIA conference. To date, the 10x10 Program's partnering institutions offer survey courses across biomedical informatics, clinical research informatics, general health informatics, nursing and health informatics in clinical information and communications technologies (ICT), public health informatics, healthcare ICT, electronic health record systems, as well as basic computational issues and methods used in

molecular biology. The cost of these courses varies, with the mode being \$2,000. Most of the partner institutions offer continuing education credit with an option for its participants to gain institutional credit towards its formal degree program. Any student completing a 10x10 course also receives an AMIA certificate of completion and a complimentary one-year AMIA membership.

The AMIA 10x10 Program and its academic partners serve multiple roles within the healthcare industry. The 10x10 Program provides a channel for academic partners to perform outreach that specifically addresses challenges within the healthcare workforce, as well as recruit potential students into their formal health informatics programs. More importantly, the 10x10 courses offer continuing education opportunities in health informatics to a wide audience of professionals who in turn serve as local informatics leaders within the industry. As engaged AMIA members, the 10x10 graduates are exposed to "best practices" for effective organization, analysis, management, and use of healthcare information to support patient care, public health, teaching, research, administration, and related policy. With respect to SIGHealth members, the 10x10 Program offers similar opportunities as well as a basis for commonalities with health informatics professionals.
