Plans are taking shape for a lively SIG-Health presence at AMCIS 2014. Activities scheduled included a research workshop, numerous research presentations, and our annual SIGHealth Business Meeting. Our business meeting will be held from 6-7:30pm Friday, August 8 in Meeting Room 106 of the Savannah International Trade and Convention Center (the AMCIS 2014 conference venue), One International Drive, Savannah, Georgia. SIG-Health members and all others interested in SIG-Health are invited to the business meeting. Continuing a SIG-Health tradition, we once again plan to taste regional wines and beers during the meeting.

Here is a brief recap of the past three months.

May – Our 2013 Annual Report was prepared, delivered to AIS, and posted on the SIGHealth Website. A total of 26 research papers plus three posters are accepted for presentation at AMCIS 2014

June – Ten papers were accepted to the "Human-Computer Interaction in Health and Wellness" Research Workshop that SIGHealth is co-hosting with SIGHCI. The "invitation-only" workshop will be held in Savannah prior to AMCIS 2014.

July – Nominations for SIGHealth President-Elect and Treasurer were returned from the nomination committee chaired by Immediate Past President Rich Klein. Surendra Sarnikar is nominated for the President-Elect position and Kaushik Ghosh for the Treasurer position. Two healthcare track papers received awards at ECIS 2014.

This will be my last report as SIGHealth President, as President-Elect Gondy Leroy will take the helm during our upcoming business meeting. The SIG has grown significantly in membership over the past two years, and we have completed important structural reorganization of officer transitions, updating of bylaws, development of a mission statement, and hosting of successful tracks and workshops in conjunction with AMCIS, ECIS, and PACIS conferences during that time. I have greatly enjoyed getting a chance to meet many of our members. I thank you for your continuing support of SIGHealth, and I look forward to visiting with those of you who can attend AMCIS 2014.



Professor Vance Wilson, Opponent...

Vance Wilson

In May SIG-Health President Vance Wilson traveled to University of Oulo, Finland to participate as *Opponent* in the (successful) Ph.D. defense of student Sitwat Langrial. Mr. Langrial's thesis focuses on persuasive uses of Information Technology in health settings, an area of Prof. Wilson's expertise.

This was a very interesting experience, to say the least! *The Opponent* position is a tradition in the Nordic countries, and it is particularly formalized in Finland. Wikipedia describes the Finnish Ph.D. defense process in this way:

The doctoral dissertation takes place in public. usually in a university auditorium, with the opponent and the candidate conducting a very formal debate, usually wearing white tie, under the supervision of the thesis supervisor. It is customary for the family, friends, colleagues and the members of the research community to attend the defense proceedings. After a formal entrance, the candidate begins the proceeding by a 20-minute popular lecture (lectio praecursoria), which is meant to introduce the laymen present to the topic of the thesis. After this, the opponent gives a short talk on the topic of the defense, after which the pair critically discusses the dissertation. The proceedings take two, maybe three hours. At the end of the proceeding, the opponent presents his final statement on the work, and reveals whether he/she will recommend that the faculty accept it. After the opponent has finished, any member of the public has an opportunity to raise questions on the dissertation, although such opponents extraordinary are rare. Immediately after the defense, the supervisor, the opponent, and the passed candidate drink coffee with the public. Usually, the attendees of the defense are handed out the printed dissertation and leave with it. In the evening, the passed candidate is obligated to host a dinner (Finnish: karonkka) in honor of the opponent. Usually, the candidate invites his family, colleagues, and collaborators.
